



Endless Pawsibilities

Service Contract

This contract is between Endless Pawsibilities LLC (EP) and _____ (“Client”) for pet care which can include off-leash walks, boarding, drop-in visits, daycare, photo sessions, and pick-up delivery of pet from their home.

Endless Pawsibilities services are defined in the Client Information Sheet filled out and signed by the Client.

TERMS & CONDITIONS

1. Endless Pawsibilities owners and staff agree(s) to provide the reliable, safe and caring services to the client.
2. Emergency Medical Care:
 - a. I authorize emergency medical care to be provided for my pet(s) by the veterinarian listed in my Client Information form or an appropriate alternative to be determined by Endless Pawsibilities in the event my regular veterinarian is not available or closer care is required. I will reimburse Endless Pawsibilities for any charges related to the emergency care. I authorize representatives of Endless Pawsibilities to approve any emergency treatment recommended by the veterinarian if I am not reachable (excluding euthanasia). I agree to indemnify and hold harmless Endless Pawsibilities.
 - b. If it is deemed necessary I authorize employees of Endless Pawsibilities to administer first aid care for my pet(s) as determined by Endless Pawsibilities and I agree to indemnify and hold harmless Endless Pawsibilities.
 - c. I DO NOT authorize Endless Pawsibilities to administer or seek first aid care for my pet(s), and direct employees of Endless Pawsibilities to seek immediate veterinary care. I agree to indemnify and hold harmless Endless Pawsibilities for all results thereof.
3. It is understood that Endless Pawsibilities, Inc. shall not be held responsible for any damage to Client’s property, or that of others caused by pet(s) while under the care of EPI staff.
4. Under law dog bites must be reported to the local authorities and EPI complies with those laws. The dog owner will be liable for all medical care expenses and damages that result from dog bits to humans or other animals in the pack. Endless Pawsibilities reserves the right to refuse service if an owner’s dog causes physical harm while in EPI care.
5. Pets must be home at agreed upon time for dog walks and drop-in visits.
6. Pets must be dropped off for boarding and daycare services unless otherwise agreed upon by both parties during the service consultation.
7. DAMAGES: Client agrees to pay for damage caused to home and/or vehicle and/or property caused by Client’s animal(s).
8. BILLING: Dog Walking and Daycare services will be billed monthly in advance for clients contracting for regular services unless other arrangements are made at time of contract. Any service canceled by EPI will be fully refunded. Client may cancel dog walks with 24 hours prior notice for no fee. If less than 24 hour notice, 50% of fee will be charged. For Boarding clients 50% of payment is due at Drop-off and remainder at Pick-up.
9. EP HOLIDAYS: EP does not provide service over Thanksgiving Week and Christmas Week unless otherwise agreed upon.

Both parties have read, understood, and agreed with the contents of this contract.
